Members present: Joe M^cDonald, Chair, Curt Howell, Vice-chair, Calvin Ashbeck, Lee von Borstel, J.W. Cope, Kurt Farris, Michael Flowers, Carl Haugerud, Dennis Lundeen, Sandy Macnab, Barry Schrupf (committee secretary). John Zielinski (cereals project coordinator). (CAC membership enclosed on pages 6-7).

Item 1: Call to Order and Introductions: Curt Howell called the meeting to order at 9:10AM. Those in attendance introduced themselves and their respective affiliations. This was the first CAC meeting to utilize polycom technology, with video and audio from OSU and the Klamath County Extension Office, plus one on-the-road participant connected by phone.

Item 2: Appreciation and Recognition: Dan Curry, OSU Director of Seed Services thanked the membership for their participation in the work of the advisory committee and presented recognition certificates to Kurt Farris and Randy Black.

Item 3: The agenda was approved as distributed (page 8)

Item 4:

Item 5: Approval of the Minutes from the Nov 30, 2006 Cereals Advisory Committee meeting.

ACTION: M/S von Borstel/Cope to approve the 2006 Minutes as distributed by email. All in favor. Motion carried.

Item 6: Report – Certification and Foundation Seed and Plant Materials Board (here-in-after “the Board”).

Carl Haugerud reported that the Board met on February 13, 2007 and was informed that Washington State Crop Improvement Association would reciprocate with Oregon Seed Certification Service and not charge a poundage fee for out-of-state-movement of seed in the dirt; this concluded the topic which was initiated by the CAC in 2006. There were no recommendations from the CAC that required an action by the Board at that meeting.

Item 7: Report – Cereals Variety Advisory Committee (CVAC).

Michael Flowers reported the CVAC (June 4, 2007) recommended to the Oregon State University Variety Release Committee:

(1) Open release of Goetze soft white winter wheat (ORH010920); Goetze will be submitted for PVP without Title 5. Goetze is best adapted to the Willamette Valley and areas where the variety Gene is currently grown.

(2) Semi-exclusive release of ORN00B553 (name to be determined) hard red winter wheat; 553 will be submitted for PVP with Title 5, the semi-exclusive release mechanism should follow that of the OSU Clearfield wheat model.

(3) Hooded barley selections developed by the OSU barley breeding program be made available to interested parties through non-exclusive material transfer agreements.

Also reported: ORH010085 soft white winter wheat and ORCF103 are on track for release in 2008 and are currently in Foundation seed production.

Item 8: Report – Oregon Certification Variety Review Committee (OCVR).

Michael Flowers, Chair, OCVR reported on the efforts by the committee to develop published instructions for submitting a new variety to the Oregon Seed Certification Service program. These instructions are

based on those of the Grass Variety Review Committee of the Association of Official Seed Certifying Agencies (AOSCA), with more specific definition of data requirements (two site years, with sites specified as different natural environments, rather than ten miles distance.) The OCVR is working with turf grass breeders on the development and adoption of the “natural environment” requirement. When adopted, the application requirement will also apply to new cereals varieties, however it is not expected to impose any new data requirements on varieties from university breeding programs since current variety testing programs encompass many natural environments.

Item 9: Lee von Borstel asked “Who gets seed certification information?”

Lee pointed out that seed of cereal public varieties is often produced under contract, however the Oregon Seed Certification Service (OSCS) does not carry the contractor for public varieties and this leaves the contractor in the dark since the contractor does not receive copies of field inspection reports.

Currently, OSCS policy has been to publish field numbers and acres applied for production of public cereal varieties in the preliminary cereals public variety growers list. Also, field inspection information for public varieties is only distributed to the grower of record, and only that grower has the authority to further distribute that information. Information from seed testing can be distributed to two additional parties if that distribution is authorized as “additional cc’s” on the seed sample certificate.

Dennis Lundeen explained that the distinction between private and public varieties in the Oregon program is based on the requirement to have an approved contractor for production of private (proprietary) varieties, and that there is no such requirement for production of public varieties. This distinction is basic to the design of the seed certification databases, and is part of the programming design at multiple locations throughout the many computer programs that constitute the OSCS “database”; to change that distinction would require a comprehensive re-writing of the computer programs.

The CAC adopted by unanimous vote the following request of seed certification: “To prepare a report to the CAC regarding policies and programming requirements pertaining to carrying contractors, and multiple contractors, for public varieties, and what changes could be considered to meet the industry need for information.” Dennis indicated that OSCS would respond to the CAC with the requested report.

Item 10: Shipping certificates.

John Zielinski reviewed eight years usage of hand prepared certificates of “Final Certification” and “Transfers Pending” with e-certificates. Comparative data are available as an attachment on page 10. In the past year, use of the hand prepared certificates has been very limited; this lead to discussion of how much longer the hand prepared certificates should be made available. Kurt Farris suggested an inquiry to those who still used the hand prepared certificates to determine why they had not switched to using the e-certificates. John confirmed that all warehouses/companies that had used certificates have been provided information regarding the option of utilizing e-certificates. Joe M^cDonald indicated that the paper certificates will continue to be needed so long as a final e-certificate cannot be prepared following a transfer pending e-certificate, and Lee observed that paper certificates are needed as back-up when a computer goes down. It was confirmed that a transfer pending certificate was not needed for moving in-the-dirt seed from the farm to the warehouse, including in those cases where the original contractor sold the seed to another contractor.

Item 11: On-line seedling applications.

Dennis Lundeen discussed work being done by OSCS staff, to develop an on-line seedling application. This is being done in response to many industry requests for automation, particularly from those who prepare multiple applications and are seeking relief from the necessity of repetitive data entries, e.g. grower name, address, phone number. The concept of an on-line application was definitely supported in a conference call to county agents in Marion, Linn, Yamhill and Union Counties. Dennis discussed how the

process would work: Using pin and pass word at the OSCS website, a grower would access an electronic seedling application form. Upon completing the required data entries, the grower would be provided with a transaction number(s) unique to each seedling application. The grower would be sent an envelope to submit documents for planting stock and field map (this envelope could be mailed back to OSCS or delivered to the County Extension Office); no payment check would be submitted at that time. Upon receipt of the documents envelope at OSCS, the seedling entry would be verified and completed by OSCS staff; completion of the seedling entry into the computer database would initiate a billing.

Currently, this capability is being developed specifically for the seedling application. Once it is programmed, tested, and in operational use, (with hopes for fall of 2008), then further expansion to on-line crop sign-ups will be considered, recognizing that this is a much bigger step.

JW Cope observed that California currently has an on-line seedling application capability and utilizes Google Earth for as the photo base for the field map.

Item 12: Education and promotion regarding seed certification.

Dennis began the discussion by asking for ideas from the group of how certified seed and seed certification could be promoted, many ideas followed and included:

- Signs at the warehouse: "Approved Oregon Certified Seed Conditioner",
- Signs in fields: "Oregon Certified Wheat",
- Crop specific brochures: how certification is done and what it means,
- OSCS staff presentations at Extension Service county winter meetings and any program where pesticide credit hours are given,
- OSCS booth displays at Farm Fairs, County Weed & Crop tours
- County Extension newsletters,
- Agricultural newspaper articles, e.g. listing of approved warehouses to handle certified seed.

Joe M^cDonald suggested there might be external funding sources to develop some of the materials – Extension Service? ODA? NRCS? There seemed to be general consensus that the Washington State Crop Improvement Association does a pretty good job of promoting certified seed, as evidenced by their current estimate of 83.5% of grain acres planted with certified seed in Washington. There was specific note given to the WSCIA use of "Approved Certified Seed Plant" signs, display booth, and participation at county fairs in the wheat growing regions of the state.

Item 13: Reports.

Washington State Crop Improvement Association (WSCIA) – Jerry Robinson, Manager, WSCIA sent a written report regarding the past year's activities, including the move of the WSCIA headquarters office to the Washington State University campus in Pullman, hiring Ron Whittum as Manager, Foundation Seed Project, computer upgrades and installation of the Pure Harvest computer program, and production and sales of Foundation Seed. Jerry had been able to participate in the Cereals Advisory Committee meetings in 2005 and 2006; recognizing (1) the regional nature of certified cereals seed production and the desirability of uniformity among the PNW certification programs, and (2) the important roles of the Washington and Idaho Foundation seed projects in meeting the breeder and Foundation seed needs for Oregon cereals varieties, the CAC is hopeful of regular and continuing participation from them in future years

Oregon Department of Agriculture – no report.

OSU Department of Crop and Soil Science – Mike Flowers presented a report from Russ Karow regarding budgets, projects and staffing.

OSU Seed Lab – no report.

Oregon Seed Certification – Dennis Lundeen announced that Oregon will host the 2009 annual meeting

of the Association of Official Seed Certifying Agencies. This is a major meeting with international attendance. Dan Curry, Director of Seed Services is lead person for planning and arrangements. Dennis also reviewed the 2007 Certification Activity Summary Report and reflected a bit on expected impact of high wheat prices on acreages signed up for certification in 2008. Thus far it appears that many Willamette Valley acres sowed for winter wheat production have come out of Perennial ryegrass production.

Regarding the reporting format for the Activity Summary, and the manner in which certification categorizes crop types, Calvin Ashbeck pointed out that there is an important difference between winter rape/annual rape and the crop type Canola, the former being for industrial oil production and the latter being for edible oil production. Calvin felt the certified Canola production should be reported separately.

John Zielinski reviewed specifics from the 2007 inspection season and some comparisons to earlier seasons; those data can be viewed as attachments on pages 11-12. Discussion then followed regarding OSCS's inspection policy regarding Cereal rye. Field standards have a zero tolerance for Cereal rye found any where in the certified field, either in or out of the inspection count. Policy allows the inspector to rogue the first plant found and not reject, subject to reinspection, if no more Cereal rye plants are found. This policy was followed for four fields of 226 inspected for crop in 2007. After discussion of the policy, the CAC advised OSCS to discontinue the policy, and to reject, subject to reinspection when the first Cereal rye plant is found – the feeling being that if any Cereal rye is found, then the grower needs to do more work in the field.

Item 14: Vice-chair election.

ACTION: M/S Howell/von Borstel to nominate Kurt Farris as Vice Chair in 2008. All in favor. Motion carried.

Item 15: Other business.

Meeting place and time – there was general agreement that The Dalles location was reasonably located, considering the directions and distances that members had to travel. Escalating gas prices might necessitate consideration of other meeting formats that could reduce travel distances and costs. Dennis will look into costs of conducting a four hour meeting via polycom (visual and audio from remote locations – e.g. Klamath Falls, Pendleton, Madras, La Grande, Corvallis). A distance-meeting format might be sufficient when the agenda contained only information items; a face-to-face meeting might be preferable if changes to standards and policies are to be considered. The Tuesday of Thanksgiving week was an acceptable date.

The 2008 Fall meeting of the Cereals Advisory Committee will be November 25, 2008 at the Board Room of the Columbia Gorge Community College, The Dalles campus, unless a distance-meeting is arranged.

A summary list of CAC recommendations and information items to the Board are enclosed on page 9.

The meeting adjourned at 2 PM.
