- Permission to use proprietary varieties must be supported by proper documentation.
- Complete records must be maintained by the requesting company or its agent and be presented to the Seed Certification Service upon our request. This includes all records pertaining to the acquisition of lots, and the conditioning and distribution of this conditioned lot. Reissue lots must have had a viability test completed within the last 18 months.
- All certification tags of the inbound lot and extra certification tags issued for this request must be bundled in small groups, rubber banded and forwarded to the Seed Certification Service within ten days of completing the conditioning process. A copy of this form with the final weight and sack count must be included with the tags.
