Oregon Certification Acreage Sign-up Status for 2010

The Oregon Seed Certification Service prepares a status of sign-ups for Oregon certification each year.

We are reporting this year's acreage sign-up for Oregon Certification, as of April 30, 2010; Totals are 176,738 acres representing 4,035 fields (-46,375 acres, a decrease of 21% over last year) this compares to the previous sign-up acreage;

Crops showing an **increase of more than 1,000 acres** in acreage signed up for Oregon certification over 2009 figures are: Annual ryegrass (+1,103 acres, an increase of 22% over last year).

Crops showing a **decrease of more than 1,000 acres** in acreage signed up for Oregon certification over 2009 figures are: Chewings fescue (-2,499 acres, a decrease of 30% over last year), Creeping bentgrass (-2,276 acres, a decrease of 59% over last year), Kentucky bluegrass (-4,303 acres, a decrease of 37% over last year), Perennial ryegrass (-4,890 acres, a decrease of 10% over last year), Tall fescue (-29,756 acres, a decrease of 29% over last year).

Overall acreage totals will change as additional and late sign-ups come in and also where fields are withdrawn prior to inspection. Reviewing this year's response from seed growers, the acres reported for Oregon Certification inspection are as follows:

72% of the acreage has been signed up for inspection, 4% of the acreage is not to be certified this year, and 24% of the acreage has been removed. As of April 30, 2010 there are 16,115 acres yet to be accounted for and could be signed up for 2010 inspection.

Oregon Certification is not complete until all record checks, field evaluations, and seed testing meets all standards and Oregon certification tags are issued and attached to individual bags of seed. Certification bulk shipping certificates can also be used with bulk or bag cereal grain.
